International Finance - Accounting Frameworks, Foreign Exchange Rates and Coupons, Flexible and Fixed Foreign Exchange Rates, Financial Crises and Responses, Monetary Union 6. International Development - Development Concepts, Growth and Development, International Manufacturing and Development, Structural Change and Adaptation 7. International Institutions - International Organizations (IMF, World Bank, OECD, ILO, G20, G8, World Economic Forum, ...) and international trade blocs (NAFTA, EU, MercoSur, ASEAN, TPP, etc.).
